Release and Statement of Indemnification

2021 Forest Grove Holiday Light Parade Rules and Regulations

1. The safety of all parade participants and spectators is your primary concern, above all other considerations
2. All entries must be illuminated
3. This is a family friendly event
4. No air horns are allowed, as they frighten horses and other parade animals
5. All candy or giveaways must be handed out by walkers only.
6. No candy or giveaways will be thrown or projected from vehicles, mounts, or floats
7. Entries with animals must provide their own clean up
8. There is a 14 foot height restriction for all entries
9. Children must be under adequate adult supervision, no more than 5 kids to 1 adult
10. Skidding or peeling out of tires is strictly prohibited
11. All entries must complete a registration form in advance
12. Santa is contracted by the Western Washington County Firefighters Association. There cannot be any other Santas in the parade, decorative or inflatable Santas are allowed
13. All participants will follow instructions from parade volunteers
14. Parade staging opens at 3:00 pm on December 4, and is located on Bonnie Lane (east of Aspenwood). Please enter the parade staging area from the B Street and Bonnie Lane intersection
15. Entry numbers and additional instructions will be issued upon arrival
16. Entries in violation of any guideline will be turned away at the staging area
17. The parade begins promptly at 5:00 pm
